As the City's Placemaker Public Art Program prepares for the spring installation of new art throughout Saskatoon's key commercial districts, residents may notice some changes in these areas over the next few weeks.

Currently, the City is accepting proposals for the Placemaker Program from independent artists or teams of artists to provide temporary public art to key commercial districts in Saskatoon. The proposed art may be two or three dimensional work, installations, interventions or digital media such as video projection.

The deadline for applications is April 8, 2014 at which time the City's Visual Arts Placement Jury will adjudicate the applications received and select the works to be exhibited, in consultation with the Saskatoon's Business Improvement Districts and with City Staff.
