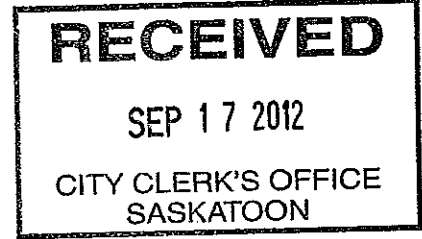

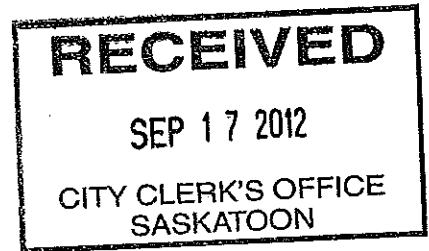

COMMENTS:

For a year prior to the slope failure at Cherry Lane concerns and warnings had been conveyed to the city (Transit and Infrastructure) by many residents including myself about the increased amount of tremor activity caused by bus traffic and how it may be affecting the delicate slope at that location. The only response was that this was unfortunate and that someday perhaps lighter buses would be utilized. Some pot holes were filled as well which did little to solve the major issue. Just one month prior to the slope failure I again followed up with an email to Transit indicating that the problem was getting worse and enquired about the status of altering the bus route if lighter buses could not be utilized. To this day I have had no response and in the interim the slope failed and lighter buses are now suddenly being utilized.

In every correspondance to each department, I was clear as to the severity of the situation yet no one bothered to quantify the concerns. In speaking to Golder Associates they indicated that transit vibration has absolutely nothing to do with slope failure which makes it no surprise that it was not even considered or mentioned in the report that residents received, yet lighter buses were immediately put in place. Understanding that rain saturation was the main cause, to mention residential landscaping as a contributing factor but not ground tremors does not intuitively make sense to me. I might have agreed if it were garden variety vibrations and not the degree of intensity actually experienced, especially after heavy rainfall.

Faults and causes aside, I think the City's lack of care and response prior to and leading up to the slope failure unacceptable. I was under the distinct impression that my individual concerns were beyond the scope of the departments I communicated with and were, as such, being dismissed. My hope is that, in the future, City departments might exercise more concern and communication amongst themselves with regards to validating citizen's concerns and possibly averting situations such as this.

I realize that I am applying very late and may not receive approval, however, I am hoping you will consider this application!

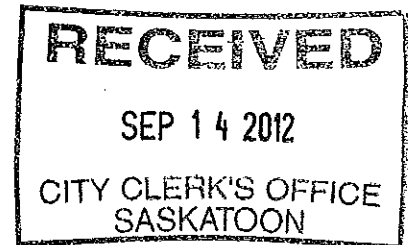

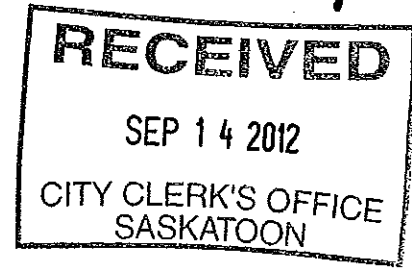

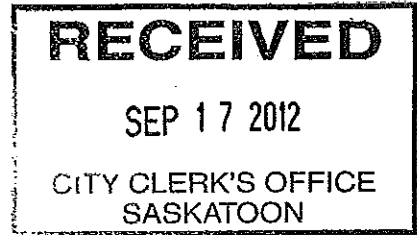

- RECOMMENDATION:**
- 1) that the tender submitted by Garnett Industries Ltd., for Contract 12-0075; 37<sup>th</sup> Street Extension and Richardson Road Storm Sewer Replacement, at a total estimated cost of \$1,263,344.25 including G.S.T., be approved;
  - 2) that a post budget increase to Capital Project 1416-11 – Trunk Sewers – Hampton Village – Storm Trunk EI, in the amount of \$532,000, be approved;
  - 3) that the post budget increase in the amount of \$532,000 be funded from the Trunk Sewer Reserve; and
  - 4) that His Worship the Mayor and the City Clerk be authorized to execute the contract documents, as prepared by the City Solicitor, under Corporate Seal.

### **REPORT**

Replacement of the Richardson Road storm sewer, from 37<sup>th</sup> Street to Cole Avenue, is required to upgrade its capacity and accommodate future development in the region. This replacement will be done by removing and disposing of the existing storm line and manholes, and replacing them with a larger and deeper storm line. The line will connect the newly established storm line from Hampton Village to the existing Westview storm trunk sewer. The work is required to be done in the fall of 2012 in order to mitigate potential impacts to the Hampton Village storm sewer system and dry pond during the 2013 spring melt.

The contract also covers another project in the same area: the extension of 37<sup>th</sup> Street where it currently comes to an abrupt end. The extension will encompass the construction of a cul-de-sac and the development of three new lots.

Tenders were opened publicly on September 11, 2012. One tender was received from Garnett Industries Ltd. of Saskatoon, Saskatchewan, in the amount of \$1,263,344.25, including G.S.T.

Garnett Industries has successfully completed similar projects for the City in the past.

### **FINANCIAL IMPACT**

The net cost to the City for the low and only bid, submitted by Garnett Industries, is calculated as follows:

Base Tender Amount	
Richardson Road Storm Replacement	\$ 871,740.00
37 <sup>th</sup> Street Extension	\$ 261,445.00
Contingency	\$ 70,000.00
G.S.T.	\$ 60,159.25
Total Tender Price	\$ 1,263,344.25
Less G.S.T. Rebate to the City	\$ 60,159.25
<b>Net Cost to the City</b>	<b><u>\$ 1,203,185.00</u></b>

The Engineer's final estimate for total tender price was \$953,289.75 including G.S.T. for the work.

There are two capital project sources for this work, with approved funding in the amount of \$813,000 as follows:

- Capital Project 1416-11 – Trunk Sewers – Hampton Village Storm Trunk EI – \$500,000; and
- Capital Project 1400-12 – Land Development – Hampton Village – 2009-E3-City \$313,000.00

Administration and engineering costs are estimated to be approximately \$142,000. Therefore, the total estimated funding required for this project is approximately \$1,345,000, resulting in a shortfall of \$532,000.

There is adequate funding for the 37<sup>th</sup> Street extension; however, an additional \$532,000 is required to complete the Richardson Road storm sewer extension. The Administration is recommending a post budget increase in the amount of \$532,000, to be funded from the Trunk Sewer Reserve. There is sufficient funding from the overall Prepaid Service Reserves.

**ENVIRONMENTAL IMPLICATIONS**

There are no environmental implications.

**COMMUNICATIONS PLAN**

The construction is expected to have an impact on traffic on 37<sup>th</sup> Street, east of Richardson Road and Richardson Road from 37<sup>th</sup> Street to Cole Avenue. Any required traffic detours will be communicated to the public via Public Service Announcements. Construction notifications will also be delivered to the homes of residents adjacent to the work area.
