CHILDREN RIDE TRANSIT FOR FREE THIS FALL. HAVE YOUR SAY IN HOW IT ROLLS OUT.

Starting September 2024, Saskatoon Transit will provide free child fare on our fixed-route buses and Access Transit. We need your valuable insight to design a program that makes Saskatoon Transit more accessible and affordable for families and individuals in our community.

Many Canadian transit agencies now provide free fares for elementary-school-aged children, including the City of Regina (Fall 2022). In November 2023, the Governance and Priorities Committee (GPC) resolved that the implementation of fare elimination for children be considered effective for September 2024. The current transit fare for children between the ages of five and 13 is \$2.25.
