## Monthly Rates (Effective Nov 1, 2024)

The City of Saskatoon sets its utility rates to match those established by SaskPower. This is to create fairness in rates and equality between utility customers regardless of whether they live within Saskatoon Light & Power's or SaskPower's service areas.

Request for research: Customer initiated and covering periods in excess of the immediately preceding 12 months	\$25 for each year researched
Self-Generation Application	\$300
Self-Generation Interconnection Study	Actual cost
Self-Generation Interconnection Upgrades	Actual cost
Polyphase/Transformer-Rated Bi-Directional Meter for Self-Generation	Actual cost
Service Tamper Charge	\$400 or actual cost, whichever is greater.
