# **Commercial Business Licence**

The City of Saskatoon Business Licence Bylaw requires that all businesses operating from a permanent commercial property in the City of Saskatoon, obtain a business licence prior to starting operations. A business licence is nontransferable and is only valid for the location specified on the licence.

### What is the purpose of a business licence?

Business licences are required for the following reasons:

- to assist with safe and orderly commercial, industrial and institutional development
- to ensure compliance with land-use and building regulations
- to gather land-use information and business statistics which contribute to future development policies
- to guide planning decision making processes

### Standards to consider before starting your business:

### **Zoning Designation**

Prior to finalizing the location of your business, you should contact Planning & Development to determine that the zoning or land-use designation permits your proposed use. For more information contact the Development Review Section at 306-975-2645.

### **Building Permit**

Building permits are required for:

- all new construction
- structural changes to existing buildings
- change of occupancy or use of an existing building, etc

Prior to selecting a structure for your business, contact Building Standards for information regarding building permit requirements at 306-975-7639.

### Parking, Landscaping & Sign Regulations

To determine if any other regulations may apply, please contact a Bylaw Inspector at 306-975-2645.

### How long is a business licence valid and how is it renewed?

A business licence is valid for one year from the date it is issued. The expiration date is noted on the business licence. Annual renewal forms are mailed approximately six weeks prior to the business licence expiring. Renewal notices are to be returned with all applicable changes noted on the form with the appropriate fee. If the business relocates to a new site or structure the renewal fee is \$135. All other renewals are \$95. There is no charge to file a Change of Business Ownership or Business Name.

Submit your completed form, any supporting documents, and the appropriate fee by mail or in person to the address noted above.

### The Process

Business Licence Program staff will review your application for compliance with land-use and building regulations. If required, your application will be referred to affected departments of the City and other government agencies for consideration. If there are any questions or additional information is required, our staff will contact you. Once your application is approved you will receive written confirmation by mail, included with your business licence. Being granted a City of Saskatoon business licence does not relieve the applicant from complying with all Municipal Bylaws or Provincial and Federal legislation.

NOTE: It will take 10 to 15 business days to process your business licence application.
