CONTRACTOR'S LIABILITY

The contractor shall protect himself and indemnify and save harmless the City of Saskatoon from any and all claims which arise from the contractor's operations or which result there from, including claims for bodily injury, death or property damage and for this purpose shall, without restricting the generality of the foregoing, maintain insurance coverage for public liability, property damage, vehicle liability and property damage insurance in the amounts specified for contractors contracting out work for the City of Saskatoon.

LIVE TAPPING

The City of Saskatoon is continuing a pilot project which would allow contractors to perform their own 25mm (1") diameter tappings. If the contractor would like to perform their own tappings, please provide which employees will supervise/perform the tappings and their training, a written procedure for the tapping as well as which equipment will be used. The procedure will go through a review process before any tappings are attempted. Tappings will need to be approved at time of booking. Performance of tappings will be reviewed and approval may be revoked based on performance. An inspector must be present when tapping is performed.

WATER & SEWER CONNECTION BOUNDARIES

Water and sewer connections can only be installed by a water and sewer contractor up to the 1m envelope of a structure. Once the water and sewer services enter the 1m envelope of a structure, including garages, the water and sewer pipes are considered plumbing and are governed by the National Plumbing Code. This means that the section of the water and sewer services under a garage, and the section between a detached garage and the main building are both considered plumbing and must be installed by a licensed plumbing contractor and adhere to the National Plumbing Code.

GENERAL INFORMATION

An "inspection" as defined for the purpose of the cash connections charge out rates means one (1) trip by a City of Saskatoon inspector per street address.

If you do not have a copy of the current City of Saskatoon Standard Construction Specifications and Drawings, these may be obtained from https://www.saskatoon.ca/business-development/development-regulation/specifications-standards/specifications. The types of pipe which are permitted for use are listed in the current City of Saskatoon Standard Construction Specifications and Drawings.
