Proposed Bylaw Nos. 10062 and 10063

Saskatoon City Council will consider amendments to the Official Community Plan Bylaw No. 9700 by way of Bylaw No. 10062, Official Community Plan Amendment Bylaw 2025 (No. 2) and to the City's Zoning Bylaw No. 9990 by way of Bylaw No. 10063, The Zoning Bylaw Amendment Bylaw, 2025 (No. 4).

The City of Saskatoon is proposing text amendments to the Official Community Plan. Section G1.2 Infill Growth currently limits the development of secondary suites to one-unit dwellings, and the proposed amendment will allow a secondary suite to be developed in a semi-detached dwelling.

The City of Saskatoon is proposing amendments to Section 5.3.23 of the Zoning Bylaw to permit a secondary suite to be developed in a semi-detached dwelling. Regulations for required access to the mechanical room from the principal dwelling are also proposed to be removed.

The purpose of the amendments is to provide options for the development of housing units consistent with existing policies.




