About ENGLISH RIVER FIRST NATION

English River First Nation (ERFN) is comprised of nineteen different Reserves. Prior to signing Treaty 10, The Poplar House People resided at seven historical settlements, including: Cree Lake, Porter Island, Elak Dase, Knee Lake, Dipper Rapids, Wapachewunak, and La Plonge. The home reserves are located at Wapachewunak, near the Churchill River, and La Plonge, on the Beaver River. The river provides transportation and allows for fishing, hunting, and gathering. It also provides economic opportunities for outfitting and tourism. English River First Nation is a Dene and Cree community. ERFN has a vibrant economy with many people owning businesses or being employed through the First Nation.

HIGHLIGHTS AND OPPORTUNITIES

- On August 28, 1906, Chief William Apesis signed Treaty 10 on behalf of English River First Nation.
- Des Nedhe Group, ERFN's economic and employment development entity, continues to create economic and employment opportunities for their members.
- Tron Construction & Mining, 100% owned by ERFN, provides multi-disciplinary general contracting services as well as heavy earth moving in mining, construction, and maintenance contracts.
- English River Enterprise, 100% owned by ERFN, operates Grasswood Travel and Business Centre south of Saskatoon, which includes 80,000 square feet of office space, a gas, convenience and liquor store, two commercial strip malls, and other warehousing buildings.
- Creative Fire, 100% owned by ERFN, offers public and media relations; Indigenous inclusion and community engagement strategies; design and content for digital, print and social platforms; event planning and management.
- Neetah Construction, 51% owned by Des Nedhe, is a multiservice, multi-disciplinary, heavy civil and roadbuilding construction and maintenance company.
- Forestry and mining are key partners and employers of ERFN.

HOME RESERVE INFORMATION

Location

The home reserves are located at Wapachewunak, west of the Shagwanew Rapids on the Churchill River and at La Plonge, located on the Beaver River. English River First Nation is both a Dene and Cree speaking community that is accessible by Provincial Road 918.

Services

Community facilities include: band office, Canada Post office, William Apesis Memorial band hall, St. Louis School, Great River Health Clinic, CPAT 89.9 radio station, youth centre, gas bar, fish plant, day care, Ovide G. McIntyre Memorial Arena and Curling Rink, St. Louis Roman Catholic Church, RCMP detachment, and Lein Wolverine Park.

Education

Education has always been important to ERFN. Historically, children attended residential schools in Ile a la Crosse and La Plonge Reserve. A local elementary school, St. Louis School, was built in 1971, with a modern successor in 1995. In 2000, it was updated and expanded to include a high school, eliminating the need for students to travel outside the community for educational training.
