# **About PETER BALLANTYNE CREE NATION**

Peter Ballantyne Cree Nation (PBCN) has occupied lands in Northeast Saskatchewan since time immemorial. Peter Ballantyne Cree Nation is called Assin'skowitiniwak, which means "people of the rocky area". Peter Ballantyne Cree Nation consists of 8 communities, including Denare Beach, Deschaumbault Lake, Kinoosao, Pelican Narrows, Prince Albert, Sandy Bay, Southend, and Sturgeon Landing, and is spread over 51,000 square kilometers. Peter Ballantyne Cree Nation follows the traditional lifestyle of the Woodland Cree, which led to the establishment of several communities along major economic routes including various waterways (<u>http://www.pbcnhealthservices.org/</u>). The majority of PBCN members live in the traditional territory of the 8 communities, but there are also many members living in urban centres such as Prince Albert and Saskatoon.

### **HIGHLIGHTS AND OPPORTUNITIES**

- On February 11, 1889, Commissioner Irvine met with the Montreal Lake and Lac La Ronge First Nations at Molanosa at the north end of Montreal Lake at the outflow of the Montreal River, concluding an adhesion to Treaty Six. It had the same terms as Treaty Six, 13 years prior.
- Peter Ballantyne was appointed as the first Chief, serving in that capacity until 1917.
- PBCN has a wide range of services for its members, including businesses owned completely by the Band and others in partnership.
- Peter Ballantyne Group of Companies (PBGOC) emphasizes the development and maintenance of good relations with strong partners. PBGOC currently participates in over 20 businesses including the Northern Lights Casino and Tim Hortons located in Creighton. (<u>http://pbgoc.com/</u>)
- PBCN has 14 elected Councillors two each from Southend, Sandy Bay, and Deschambault Lake, five from Pelican Narrows, and one each from Denare Beach, Sturgeon Landing, and Prince Albert.

### **RESERVE INFORMATION**

### Location

Peter Ballantyne Cree Nation is comprised of 8 communities including Denare Beach, Deschaumbault Lake, Kinoosao, Pelican Narrows, Prince Albert, Sandy Bay, Southend, and Sturgeon Landing.

#### Services

Peter Ballantyne Health Services: Treaty 6 includes a 'medicine chest' clause, provided at the request of the people for medical care. This treaty relationship between the Crown and First Nations of Canada remains as the foundation upon which the PBCN Health Transfer Agreement was signed in April 1995 and in all agreements since (*pbcnhealthservices.org*). A wide range of home, community and primary care services are provided at the central location in Prince Albert and other community facilities. Services vary by community.

#### Education

"All children are gifts of the Creator and as such they are sacred beings to be treated with the necessary dignity and respect. The whole community is involved in the education of children, an education that is holistic and that rests on the culture and values of the Woodland Cree" (*pbcnea.ca/mission-and-vision*). PBCN Education Authority is the largest First Nation education system in Saskatchewan. It owns and administers 7 schools and has a total student population of approximately 1800 students.
